## 1. Introduction

- 1.1. Together with our website terms and conditions of use, this Policy governs how you may use this website (the Site).

- 1.7. Definitions

Policy

You or your

means the person accessing or using the Site or its Content.



- 1.8. We reserve the right, at our sole discretion, to change, modify, add or remove portions of this Policy, at any time. It is your responsibility to check this Policy periodically for changes. Your continued use of the Site following the posting of changes will mean that you accept and agree to the changes.

## 2. Agreement to Terms

- 2.1. These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (you), and Nubian Center, located in United Kingdom (we, us), concerning your access to and use of the Nubian Center (nubiancenter.com) website as well as any related applications (the Site).
- 2.2. The Site is an e-commerce platform that sells a curated selection of home décor, electrical gadgets, and jewellery designed to reflect a premium lifestyle offering. You agree that by accessing the Site and/or Services, you have read, understood, and agree to be bound by all of these Terms and Conditions.
- 2.3. If you do not agree with all of these Terms and Conditions, then you are prohibited from using the Site and Services and you must discontinue use immediately. If you have details connected to you or your business on the site, then please delete your content from the site to indicate that you no longer wish to use the site. We recommend that you print a copy of these Terms and Conditions for future reference.
- 2.4. The supplemental policies set out in this document, as well as any supplemental terms and condition or documents that may be posted on the Site from time to time, are expressly incorporated by reference.
- 2.5. We may make changes to these Terms and Conditions at any time. The updated version of these Terms and Conditions will be indicated by an updated "Revised" date and the updated version will be effective as soon as it is accessible. You are responsible for reviewing these Terms and Conditions to stay informed of updates. Your continued use of the Site represents that you have accepted such changes.
- 2.6. We may update or change the Site from time to time to reflect changes to our products, our users' needs and/or our business priorities.
- 2.7. The information provided on the Site is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country.
- 2.8. The Site is intended for users who are at least 16 years old. If you are under the age of 16, you are not permitted to register for the Site or use the Services without parental permission.

  - 2.9.3. Certain parts of this Site can be used only on payment of a fee. If you wish to use such Services, you will, in addition to our Terms and Conditions, also be subject to our Seller and Buyer Policy found on <https://nubiancenter.com/terms/>
  - 2.9.4. Our Acceptable Use Policy that are a set of rules that defines what may or may not be done with the assets and data within a website, network, or service. It is

### 3. Acceptable Use

- 3.1. You may not access or use the Site for any purpose other than that for which we make the site and our services available. The Site may not be used in connection with any commercial endeavours except those that are specifically endorsed or approved by us.
- 3.2. By using the site, you agree to the Acceptable use policy of the site.

#### 4. Information you provide to us

- 4.1. You represent and warrant that: (a) all registration information you submit will be true, accurate, current, and complete and relate to you and not a third party; (b) you will maintain the accuracy of such information and promptly update such information as necessary; (c) you will keep your password confidential and will be responsible for all use of your password and account; (d) you have the legal capacity and you agree to comply with these Terms and Conditions; and (e) you are not under the age of 16 in the jurisdiction in which you reside, or if you are, you have received parental permission to use the Site.

If you know or suspect that anyone other than you knows your user information (such as an identification code or user name) and/or password you must promptly notify us at [service@nubiancenter.com](mailto:service@nubiancenter.com).

If you provide any information that is untrue, inaccurate, not current or incomplete, we may suspend or terminate your account. We may remove or change a user name you select if we determine that such user name is inappropriate.

- 4.2. - 9.3. Whether you are a consumer or a business user:
  - 9.3.1. We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors and for fraud or fraudulent misrepresentation.



9.3.2. If we fail to comply with these Terms and Conditions, we will be responsible for loss or damage you suffer that is a foreseeable result of our breach of these Terms and Conditions, but we would not be responsible for any loss or damage that were not foreseeable at the time you started using the Site/Services.

9.4. Notwithstanding anything to the contrary contained in the Disclaimer/Limitation of Liability section, our liability to you for any cause whatsoever and regardless of the form of the action, will at all times be limited to a total aggregate amount equal to the greater of (a) the sum of £1,000 or (b) the amount paid, if any, by you to us for the Services/Site during the six (6) month period prior to any cause of action arising. 9.5.1.8. any indirect or consequential loss or damage

9.5.2. If you are a consumer user,

9.5.2.1. Please note that we do not directly sell products to you but function to connect you to service providers who supply you with physical or digital goods or services. We are not liable for any losses you may suffer, whether physical or financial, when you purchase or receive a service via the site from an approved or unapproved seller or service provider. We will work with you within the limits of our terms and conditions for the purpose of trying to remedy any losses you suffer, physical or financials.

9.5.2.2. Please note that we only provide our Site for domestic and private use. You agree not to use our Site for any commercial or business purposes, and we have no liability to you for any loss of profit, loss of business, business interruption, or loss of business opportunity.

## 10. Term and Termination

10.1. These Terms and Conditions shall remain in full force and effect while you use the Site or Services or are otherwise a user of the Site, as applicable. You may terminate your use or participation at any time, for any reason, by following the

- 10.2.   - 11.2.8. use the application to send automated queries to any website or to send any unsolicited commercial e-mail; or
  - 11.2.9. use any proprietary information or any of our interfaces or our other intellectual property in the design, development, manufacture, licensing or distribution of any applications, accessories or devices for use with the application.
- 11.3. The following terms apply when you use a mobile application obtained from either the Apple Store or Google Play (each an App Distributor) to access the Services:
- 11.3.1. The licence granted to you for our mobile application is limited to a non-transferable licence to use the application on a device that utilizes the Apple iOS or Android operating system, as applicable, and in accordance with the usage rules set forth in the applicable App Distributor terms of service;
  - 11.3.2. We are responsible for providing any maintenance and support services with respect to the mobile application as specified in these Terms and Conditions or as otherwise required under applicable law. You acknowledge that each App Distributor has no obligation whatsoever to furnish any maintenance and support services with respect to the mobile application;
  - 11.3.3. In the event of any failure of the mobile application to conform to any applicable warranty, you may notify an App Distributor, and the App Distributor, in accordance with its terms and policies, may refund the purchase price, if any, paid for the mobile application, and to the maximum extent permitted by applicable law, an App Distributor will have no other warranty obligation whatsoever with respect to the mobile application;
  - 11.3.4. You represent and warrant that (i) you are not located in a country that is subject to a U.S. government embargo, or that has been designated by the U.S. government as a "terrorist supporting" country; and (ii) you are not listed on any U.S. government list of prohibited or restricted parties;
  - 11.3.5. You must comply with applicable third party terms of agreement when using the mobile application, e.g., if you have a VoIP application, then you must not be in breach of their wireless data service agreement when using the mobile application; and
  - 11.3.6. You acknowledge and agree that the App Distributors are third party beneficiaries of these Terms and Conditions, and that each App Distributor will have the right (and will be deemed to have accepted the right) to enforce these Terms and Conditions against you as a third party beneficiary thereof.

## 12. General

- 12.1. Visiting the Site, sending us emails, and completing online forms constitute electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures, and other communications we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communication be in writing.
- 12.2. You hereby waive any rights or requirements under any statutes, regulations, rules, ordinances or other laws in any jurisdiction which require an original signature or delivery or retention of non-



- electronic records, or to payments or the granting of credits by other than electronic means.
- 12.3. These Terms and Conditions and any policies or operating rules posted by us on the Site or in respect to the Services constitute the entire agreement and understanding between you and us.
- 12.4. Our failure to exercise or enforce any right or provision of these Terms and Conditions shall not operate as a waiver of such right or provision.
- 12.5. We may assign any or all of our rights and obligations to others at any time.
- 12.6. We shall not be responsible or liable for any loss, damage, delay or failure to act caused by any cause beyond our reasonable control.
- 12.7. If any provision or part of a provision of these Terms and Conditions is unlawful, void or unenforceable, that provision or part of the provision is deemed severable from these Terms and Conditions and does not affect the validity and enforceability of any remaining provisions.
- 12.8. There is no joint venture, partnership, employment or agency relationship created between you and us as a result of these Terms and Conditions or use of the Site or Services.
- 12.9. For consumers only - Please note that these Terms and Conditions, their subject matter and their formation, are governed by English law. You and we both agree that the courts of England and Wales will have exclusive jurisdiction except that if you are a resident of Northern Ireland you may also bring proceedings in Northern Ireland, and if you are resident of Scotland, you may also bring proceedings in Scotland.
